7/17	Sedgwick	Sinai Hospital et al. v. Lagerald Sedgwick et al. Employee alleged HCPSS wrongfully denied payment of health insurance claim. Health claim paid and case settled.	CLOSED	
4/15	Souder v. HCBOE	Lawsuit filed. Student injured while waiting for bus with MRHS lax team. Settled by MABE on 6/16/17.	CLOSED	
12/17	Attain	HCPSS claims "Workday" contractor breached contract. Sent Notice of Termination letter 12/2017, and future payments withheld. Contractor asked for Purchasing Officer's contract interpretation, issued May 11, 2018. Attain filed suit in December 2018. Case settled.	OPEN	
8/18	Chesney, White and Thornburg v. BOE	Former employees Chesney, White and Thornburg filed civil lawsuits against the Board of Education after withdrawing the complaints that they filed with the Howard County Office of Human Rights.	OPEN	
2/18	Fagan v. Ranshaw, et al.	Individual alleged harm from bus accident caused by bus contractor. Litigation pending, and MABE is trying to set up mediation.	OPEN	
8/18	Freeman v. Lorenzo & HCBOE	Lawsuit filed by employee injured in car accident during school day. Litigation pending. MABE counsel gathering medical documentation to evaluate the claim for settlement. Trial postponed until April 15, 2019.	OPEN

Bowen's Bus Service and Board of Education	A citizen operating her vehicle on Triadelphia Mill Road filed this civil lawsuit against the Board of Education and Bowen's Bus Service, a bus contractor to the Board, alleging injuries sustained as a result of the negligent operation of a school bus being operated by Bowen's Bus Service while on a school system run. The case has been referred to the MABE Liability Pool.	OPEN	
7/17	Harris, Susan Kim	Owner of Adaptive Consulting LLC breached contract with HCPSS because not licensed to practice law in MD. Suit against Ms. Harris filed.	OPEN	
2/19	Krakower v. Howard County Public Schools Educational Foundation, Inc. et al	Bus allegedly hit Mr. Krakower's vehicle.	OPEN	
4/18	Stiles, Jr. et al. v HCBOE	Lawsuit v. BOE - property owners next to West Friendship Elementary allege that HCPSS cut down trees on their property. They seek recovery for damage caused by HCPSS including the cost of restoring the land to its original condition. MABE settled.	CLOSED
