Subject: Dual Enrollment Update

The purpose of this memorandum is to provide you with requested information on the JumpStart program. The JumpStart Program includes all students engaging in Dual Enrollment opportunities between HCPSS and HCC at all HCPSS schools. In addition to structured programs and selected courses offered at HCPSS schools, many courses may be taken at Howard Community College (HCC). If a student is interested in either earning college credit for a course they are currently taking with HCPSS or on HCC's campus, it is recommended that they work with their school counselor and the HCC Admissions and Advising counselor assigned to their school.

The existing structured and flexible program options at River Hill HS and Oakland Mills HS are offered to all students attending those high schools. The Early College Program in Cybersecurity at the Applications and Research Lab is available to all HCPSS students. Families who enrolled in JumpStart and who transferred for the 2018-2019 school year were told that if their child decided to not to continue in the program they would stay at their school of reassignment for the school year. After the 2018-2019 school year is over, students may return to their districted homeschool.

HCC has indicated that they have significant capacity to accept additional students on their campus. However, in order to maintain high school student status for sports and extracurricular eligibility, students must be enrolled in at least one course at the high school level. For the current schools offering expanded JumpStart programs (Oakland Mills and River Hill high schools), there is no fixed "Jump Start capacity." The number of seats in dually-enrolled courses is contingent upon student course requests (made in January), teacher qualifications, and HCC's capacity to support course work. The physical capacity at each school is reflected in the <u>feasibility study</u>.

In theory, every HCPSS high school student could participate in the JumpStart flexible option. The cost breakdown for the current JumpStart program cohort is included in Appendix A. It is important to note that the tuition amounts are projected based on past enrollment percentages and are subject to change based on student election to receive college credit. The future projections for tuition costs for students receiving FARMs are only applicable to current students and their trailing siblings and are found in Appendix B. These projections do not include additional JumpStart programs proposed in the recent work session on strategies to alleviate overcrowding.

# Jump Start Program Per Student Cost for School Years 2019-2023

Calculating a single per-student cost is difficult as there are several factors to consider. For evaluative purposes, the analysis breaks down the cost for a student taking one Dual Enrollment course offered at HCPSS, and one student in a structured program taking four courses on HCC's campus per semester. These per student costs will vary as HCC tuition rates change year-to-year, but the below is indicative of **annual** typical per-student costs for HCPSS.
