Good morning BOE members and Dr Martirano,

I am writing to you as a concerned citizen of Howard County based on last night's BOE meeting. I know most of you personally and was quite shocked and disappointed at quite a few things which I will itemize below; however, my biggest concern is the chokehold that this BOE has put Dr. Martirano and his staff in. I know most of the staff the community interfaces with personally as well and they have done an excellent job making the community feel a part of the HCPSS, particularly when it comes to policies and joint community activities.

I have been in this county for over 30 years and have seen many Superintendents. Dr. Martirano and his staff are truly and honestly committed to community partnership and interaction, but he has been put in a position of choosing between protecting his staff (who works extremely hard) and providing support to the community. Here is an example to make it crystal clear...at our CAC meeting on Wednesday, March 13, there was a risk that the meeting would be cancelled, after everyone was in attendance because there was not a BOE member present. Why does the Superintendent feel he has to possibly take that course of action? Perhaps the BOE collective needs to discuss this and hold one another accountable for making the Superintendent feel this is a decision he must make or he and his staff will have repercussions and a tongue-lashing. I want everyone to consider the following:

- 1) people made sacrifices to come to the CAC meeting to hear a topic discussed, including some getting childcare. Do you really want to dismiss and discount the importance of their time?
- 2) the CAC membership is entitled to hear from the HCPSS independent of whether a BOE member is present or not...last year, we didn't have a BOE

representative at more than half of the meetings. According to the bylaws, the BOE has no role but to share information.

3) CAC is expected to be an advisory to the BOE based on topics of interest where the HCPSS is knowledgeable and should be trustworthy. Why do they have to be babysat. In over 10 years since my involvement, this has never been the case.

Regarding the decisions and discussions last night, my concerns are as follows:

1) if the BOE feels that 4 years on the obrc is too much and compromising, why doesn't their appointee follow the same logic? Why did the BOE vote that their personal appointee is an exception? It gives the appearance that there are separate rules for the BOE hand-selected folks that circumvents the concerns. This appears to me as a privilege and mis-use of power and authority. I noticed the same regarding particular BOE members having more members of their support group in the Educational Equity policy.

2) a BOE member is making recommendations to include a group in a charter who she has personal bias towards based on her campaign. Candace Dodson-Reed, Sabina Taj's campaign manager, formed the African-American Community Roundtable (AACRT) — now she wants them written into the OBRC charter? I would suggest someone look at the contributions of the AACRT to any policy team or HCPSS effort. You will notice their lack of participation...so why are they being rewarded?

3) a BOE member is making a recommendation to include a special interest group (PFLAG) who makes up less than the population of many other groups in the HCPSS such as Chinese, Korean, Indian, who have been more involved over the past few years than PFLAG. How does a special interest group that composes such a small population warrant inclusion in a charter?

What happened last night concerns me. Is this really where we are as a county? What incentive do other groups, who have true two-way partnerships with the HCPSS have to continue when there is clear favoritism and bias? Most of the groups identified for inclusion in the charter have one way partnership, they want the HCPSS to do for them. Most don't participate on a policy to provide input unless it benefits their political or personal agendas. Are the rest of the BOE members oblivious to the fact?

I think a consequence of behaviors such as last night by the BOE will result in less community participation by valuable partners. Is this what the collective BOE wants?
