Good afternoon, Mrs. Coombs,

I hope this email finds you well. It is always our hope that PTAs work closely with their principal when purchasing items or planning any event and that both parties are in agreement. In the case of the yard signs for fifth graders, if PTAs ask for the principal's input, principals will not be in support of this item. If the PTA goes ahead and purchases this item, regardless of what the principal says, then you are correct, the PTA can purchase.

Regarding the high school signs, all high school principals, including Cedar Lane and Homewood, moved forward in purchasing because all of them worked together to ensure that all_seniors would have a sign. We have been stressing with our principals that we are a school system and not a system of schools, and to be as consistent as possible when it pertains to student recognition. We have followed the same premise, as we have been very careful to be as consistent as possible with all senior activities. In addition, we are extremely sensitive to our seniors this year and do not think it is necessary for a fifth grader to have the same recognition as our seniors since this is the first year we are using yard signs for seniors.
