Dear Board Members,

I am writing based on a concern brought to my attention by a few community members following the recent email from Dr. Burks about the addition of 3 Early childhood classes to Fulton ES.

While I support the Early Childhood programs and understand their importance to preparing students for Kindergarten and beyond (studies showing future educational success can be fundamentally attributed to better early-education starts), I question the placement of these programs at Fulton ES.

Fulton ES was among the higher Utilization Rate schools during redistricting and with the sheer number of homes being built in the immediate area, future projections had Fulton ES among the highest ES in the County. The Board ultimately decided to shift ~180 students out of Fulton to alleviate the overcrowding. At the time of redistricting, Fulton ES was around 115%.

A response forwarded to me from Dr. Burks regarding the Utilization of Fulton ES with the

Early Education programs estimates nearly 118% utilization. That does not bode well for the future growth the area will still see, nor does it indicate that any permanency of these Early Childhood programs is expected.

Whether the board has direct say into where these programs are placed or not, I would request that it be reviewed by the Board or that the Board request the appropriate departments within HCPSS to review this decision and provide feedback.

I welcome any details or explanation so that I (and other families) can have a better understanding of the decision. I can theorize on reasons, but without any additional information or insight, those are no better than guesses. As it stands, it seems to make everything that happened during redistricting almost irrelevant which does not seem like it aligns with the Board's intent (nor the effort put in).

Any information or response is appreciated.
