As part of the Energy Policy Act of 2005, Congress enacted Section 179D of the Internal Revenue Code to encourage the design and construction of energy efficient buildings. Per IRC §179D(d)(4) and Notice 2008-40, government entities may allocate the energy efficient commercial buildings deduction to taxpayers that create technical specification for the installation of energy efficient commercial building property as part of the interior lighting, HVAC and hot water systems, or building envelope systems. ## SECTION 179D ENERGY EFFICIENT COMMERCIAL BUILDINGS DEDUCTION ALLOCATION FORM
