Remove	While I have no issue with the subject matter of this book, I do think some of the images are explicit and, left in a media center, would offer students an opportunity to engage with it without guidance and support. If librarians will be hosting book clubs, discussion groups, and/or instruction around this book (or if it can be included in classroom instruction), then I will be more comfortable with its retention.
Remove	Inappropriate Illustrations	I do not believe this book is as bad as the hype makes it out to be. It is NOT pornographic. It does, however, cross the line of age-appropriateness on one or two occasions with its illustrations. One such illustration depicts oral sex. I do not have a problem with the text associated with this picture even though it is "sexting." When taken in context with the rest of the book, the highly publicized parts of this book are not nearly as scandalous as they originally seemed. The book definitely does not adhere to the idea that one simply does not talk about sex; it has a very cavalier approach to sex as opposed to private. But once you get passed this, there really isn't anything too shocking. The illustrations are what caused me concern. In the end, I based my recommendation on the movie industry. Movies cannot show the actual act of oral sex to a 14 year old. And for that, I recommend that the book be removed. What a shame.
	This book encourages minors to participate in the delinquent activity of accessing porn, praising it among high school students (p. 116-117) and directly providing a link to a porn website, kink.com (p. 157). Encouraging or aiding a minor to partake in a prohibited act or delinquent activity such as accessing porn is a crime.	
	The book, Gender Queer, goes against HCPSS policy 1020, which states that providing sexually explicit cartoons and drawings to students constitutes prohibited visual sexual harassment. Multiple committee members expressed concern about the explicit nature of the images in this book.	
	Under federal law any visual portrayals of sexually explicit behavior involving a minor are considered child pornography. This book contains multiple such images. The fact that they are cartoon drawings does not excuse them because "The illegal act of exposing a minor to obscene images occurs through the visual representation of any depiction such as drawings, photos, images in video, and even cartoons and paintings."	
	HCPSS policy 8404 States that videos rated R or NC-17 may not be shown to students. Using this as a measure, the book, Gender Queer is not age appropriate because it's images would be rated higher than R or NC-17 if they were in movie form.	
	It is important to evaluate this book not simply by its topic or title but by its content, keeping in mind that a book in a high school library means the school is offering this book to 14 year-olds.	
Remove	The book contains explicit illustrations of sexual encounters involving children (p.135, others), masturbation (p. 61, others) Portrays and normalizes minors using erotic gay fiction (p.116) and porn "I thought gay porn was universal." There are explicit drawings of individuals having sex (p. 167, p.61). There are drawings, discussion, and use of sex toys. Sexting (p.166), graphic illustrations of oral sex (p.167) and full frontal nudity. (more detailed notes will be sent in email)	A responsible decision on this book is not a vote up or down on its topic. It is simply a decision about the actual content and images inside the book. Sexually explicit content and links to porn are not age appropriate and are against HCPSS policy. There are numerous other books and writings available that address this topic in a more school appropriate way. Multiple parents expressed concern about this book in our schools, for good reason.

Verdict: This book should not be retained in Howard County School Libraries or as part of a school curriculum due to its sexually explicit content and illustrations. It also champions porn use among minors and provides the web address of a porn site.

It is important to evaluate this book not simply by its topic or title but by its content, keeping in mind that a book in a high school library means the school is offering this book to 14-year-olds.

The book contains:

- 1. Explicit illustrations of sexual encounters involving children p.135, others
- 2. Masturbation p. 61, others
- 3. Portrays and normalizes minors using erotic gay fiction p.116 "Interest In erotic gay fiction has been so prevalent in my friendships one could mistake it for a prerequisite" Refers to doujinshi with sexually explicit content.
- 4. P.117 "I thought gay porn was universal" Merits of gay porn vs lesbian porn.
- 5. Explicit drawings of individuals having sex p.167, p.61
- 6. Sex toys
- 7. Autoandrophilia
- 8. P. 157 Listing a porn website. According to Wikipedia: "Kink.com is a San Francisco-based bondage internet pornography company that runs a group of websites devoted to BDSM and related fetishes."
- 9. P. 166 Sexting between college students with the actual text of the sexts "I got a new strap on harness today. I can't wait to put it on you. It will fit my favorite dildo perfectly. You are going to look so hot. I can't wait to have your cock in my mouth –I'm going to give you the blow job of your life then I want you inside of me"
- 10. Graphic illustrations of oral sex P. 167
- 11. Full frontal nudity

"Students, employees, and third parties share responsibility for maintaining a school and work environment free from sexual discrimination, **sexual harassment**, and sexual misconduct. Employees, students, and third parties may be subject to disciplinary action or consequences for inappropriate behavior including that of a sexual nature, even when the behavior does not rise to the level of sexual discrimination as defined by prevailing federal and state law."

"Examples of sexual harassment include but are not limited to:"

"Visual harassment: ...posters, photography, cartoons, drawings, clothing, or gestures communicated in person or electronically."

"Sharing or pressuring someone to share (including electronically) sexually explicit material."

Prohibited: The display of symbols, images, language, materials, or items that demean an identifiable person or group or are reasonably perceived as promoting hatred, intimidation, or **harassment**

As noted above, sharing of sexually explicit material (including cartoons and drawing) is one of the specified categories of sexual harassment.

When the school provides a book on library shelves, it is sharing that book with minors. Sharing the book, Gender Queer is therefore within the category of sexual harassment, banned in our schools.

when child pornography is concerned, any depiction of a minor under the age of 18 engaging in sexually explicit conduct is unlawful.

The illegal act of exposing a minor to obscene images occurs through the visual representation of any depiction such as drawings, photos, images in video, and even cartoons and paintings. These images must show the minor some form of sexual activity in action.

If a website does not explicitly explain that graphic images or adult content are behind the agreement to enter the website, federal laws could hold the owner or admin of the site accountable for criminal activity
