#### Greetings Kendra,

After discussing internally the idea of a day trip program for HCPSS students: we are not too keen on providing that type of program this school year for several reasons. The main reason being that our core program is a residential one and it has shown to be much more effective for students through 3-5 day participation. Logistically for us it is difficult to schedule and implement day programs while in and around the residential programs and it doesn't fit the long-term effectiveness we are striving for. Lastly, experience has shown that given all of the activities available through our facility/program, a day trip program where schools are only here for 3-4 hours maximum is not ideal.

We are open to discussing and negotiating a price point for the 3-day residential program. In the past, HCPSS has paid for Free and Reduced Meal students which has allowed our program to be available to all students wanting to attend, while the remaining portion of the cost has been handled by families/participating schools. Given that model, I feel confident that we could figure something out financially that would work for HCPSS so that all students could attend our program for SY 22-23. If you are still open to exploring this further. Please let me know.

NB Subsidized cost \$225.00 per student - \$75 per student/day - \$49,500.00 total program cost based on 220 students/NB subsidizing through use of MSDE SAI Funds.

Lastly, per our discussion last week on our MSDE sponsored NorthBay Accelerated program: I have attached a 1-2 page flyer with more information detailing that program. If HCPSS is interested in enrolling students in that program we are targeting students who are below benchmarks for reading/literacy. We would welcome the opportunity to serve students through that program as well. This is paid through MSDE and is a semester-long program. Please let me know if you have any questions regarding either programming.
